



4. The Licensee is responsible in obtaining all licenses and / or other approvals from the relevant authorities.
5. The Licensor reserves the right to cancel any bookings at the Licensor's absolute discretion.
6. No cancellation will be allowed after the booking form has been signed and/or upon payment of the Booking Fee. In the event of cancellation, the Licensee shall be liable for all losses and damages suffered by the Licensor including loss in License Fee or part there of and for this purpose, the Licensor shall be entitled to forfeit all payments of booking fee and / or Security Deposit.
7. Immigration Policy (Foreign Worker Permit Policy)
